There are millions of acres of land that are managed by various electric, gas/oil and coal companies throughout the United States. These properties could be rights-of-way or other tracts owned or controlled by these energy companies and can provide an important portion of the habitat puzzle for many wildlife species, both game and non-game. This is also true for many native plants. Many of these energy companies are good stewards of wildlife and are implementing plans to improve habitat through Integrated Vegetation Management or other initiatives for managing habitats. They need an independent source to help tell the public about these safe and effective plans. Other companies need help formulating plans that maximize wildlife management.

Energy for Wildlife is a program from the National Wild Turkey Federation. It is a membership-based program for energy companies whereby they gain independent certification by being good wildlife stewards. Each company is asked to develop management plans on their own, or with help from National Wild Turkey Federation biologists, where certain objectives must be met. A sample of these includes protecting water quality, ensure long term habitat productivity, cooperating with neighboring landowners, and providing public participation opportunities. The objectives have performance measures tied to each one, ensuring that each company's plan is implemented. Since the program began in May 2002, 36 energy companies have become members and have the potential to have a positive impact on over 3 million acres.

As members, each company receives a number of benefits from the Energy for Wildlife program. Some of these include: third-party credibility for the company's wildlife habitat program, technical assistance from the National Wild Turkey Federation, assistance in relations with state and federal agencies, positive press through local and national outlets, educational opportunities, and many others.

Within this program, there are also benefits for public and private landowners. Other National Wild Turkey Federation programs could be initiated by the member company to help assist other landowners with the management of their property. Even property owned by state and federal agencies would be included in opportunities for education and public relations pertaining to managing for wildlife habitat.

With quality wildlife habitat diminishing in many areas of the United States, the Energy for Wildlife program will provide benefits to everyone involved. By managing correctly, the company should be able to control costs associated with managing rights-of-way or other long term management costs, while also providing the energy needed by the U.S. Even the landowner will see the improvement of their property. And wildlife lovers will enjoy the opportunity to see more songbirds, butterflies, native flowers, and even wild turkeys.



### What is Energy For Wildlife?

Energy for Wildlife is a membership based, wildlife management and

certification program for energy companies. The primary goal of Energy for Wildlife is to create or enhance wildlife habitat on rights of way and other company properties for the benefit of all wildlife.
